On 20 September 2021:

Any purchaser who purchases any specified residential property(ies) of the development directly through Henderson Property Agency Limited (i.e. other than other estate agents) will be entitled to select all specified residential properties including C-3/F, C-5/F, C-8/F, C-9/F in Tower 3A (81 units in total). However, any purchaser who purchases any specified residential property(ies) of the development directly through other estate agents (i.e. other than Henderson Property Agency Limited) will only be entitled to select the specified residential properties except C-3/F, C-5/F, C-8/F, C-9/F in Tower 3A (77 units in total). For the avoidance of doubt, this arrangement will be applicable on 20 September 2021 only.

Balloting

Balloting will be used to determine the order of priority. The person(s) or company(ies) interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

Group A1, Group A, Group B1 and Group B

- 1. To participate in the balloting, interested persons and previous Group A and Group B registrants who apply the "Renewal Registration" procedures must first submit a registration of intent using Registration of Intent Form A1 ("Group A1 Registration of Intent") and / or Registration of Intent Form B1 ("Group B1 Registration of Intent").
- 2. Each of the registrants (or his/her authorized person) must submit the following to 21/F, ONE IFC, Central, Hong Kong and / or 73/F, TWO IFC, Central, Hong Kong (collectively "the registration venue") during the period from 9 September 2021 to 19 September 2021 (from 10:30 a.m. to 8:00 p.m.) and 20 September 2021 (from 10:30 a.m. to 3:00 p.m.) (The order of registration will not have any impact on the order of priority for selecting the residential property):
 - (a) a maximum of one (1) Group A1 Registration of Intent and one (1) Group B1 Registration of Intent duly completed and signed by the registrants. Duplicated submission will not be accepted; and
 - (b) the Registration of Intent shall be accompanied with cashier order(s).
 - (i) Group A1 registrants must submit a minimum of one (1) but not more than four (4) cashier orders, but the number of residential property(ies) to be selected in any event shall not less than one (1) and more than four (4);
 - (ii) Group B1 registrants must submit a minimum of one (1) but not more than four (4) cashier order(s), but the number of residential property(ies) to be selected in any event shall not exceed four (4).

Each cashier order shall be in the sum of HK\$80,000 and made payable to "WOO, KWAN, LEE & LO"; and

(c) a copy of the registrant's I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).

The closing time for submission of Group A1 Registration of Intent and Group B1 Registration of Intent will be 3:00p.m. on 20 September 2021.

- 3. Registrants submitting the Group A1 Registration of Intent or Group B1 Registration of Intent and Group A Registration of Intent or Group B Registration of Intent in the previous "Information on Sales Arrangements" who have not applied the "Renewal Registration" procedures will be divided into Four (4) groups of balloting, i.e. Group A1, Group A, Group B1 and Group B in accordance with the forms of the Registrations of Intent (collectively the "Registration of Intent" and each a "Registration of Intent") they submitted, to determine the order of priority for selection of the specified residential properties.
- 4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property.
- 5. On 20 September 2021, the registrants (if the registrant is a company, then any one of its directors) who have submitted the registration in accordance with paragraph 2 above shall personally attend 21/F, ONE IFC, Central, Hong Kong ("the designated venue") between 5:00 p.m. and 6:00 p.m. ("check-in timeslot for the registrants"). The registrants whose identities have been verified by the Agent appointed by the Vendor shall be eligible for the balloting. Any registrant who arrives at the designated venue at any time later than 6:00 p.m. on 20 September 2021 shall not be eligible for any balloting and the registration of such registrant will be deemed invalid.
- 6. The balloting for Group A1, Group A, Group B1 and Group B will take place at 6:05 p.m. on 20 September 2021 and the balloting will be effected via a computer network. The balloting results, including "registration number" and "balloting result priority", will be posted by the Vendor at the designated venue on 20 September 2021. Registrants will not be separately notified of the balloting results. Every valid Group A1 Registration of Intent, Group A Registration of Intent, Group B1 Registration of Intent and Group B Registration of Intent shall be allotted such number of lot(s) which equals the number of cashier order(s) which the registrant(s) submitted with the Registration of Intent.
- 7. On 20 September 2021, the sales of specified residential properties will be divided in to 4 sessions applicable to the following 4 groups of persons who have already submitted Registrations of Intent (each group will be referred to as a "Group") (namely Group A1, Group A, Group B1 and Group B).
 - (a) The Group A1 Selection will take place first. The registrants under Group A1 shall proceed to select the specified residential property(ies) which are still available at the time of selection in the order according to the balloting result priority, once the number of the Group A1 units remaining available for selection and purchase is such that the "Additional rules" for selecting specified residential property(ies) applicable to Group A1 cannot be satisfied, then Group A1 will end.
 - (b) If there are remaining specified residential properties which are available for sale, the Group A Selection will take place after the completion of the Group A1 Selection as determined by the Vendor at its discretion. The registrants under Group A shall proceed to select the specified residential property(ies) which are still available at the time of selection in the order according to the balloting result priority, once the number of the Group A units remaining available for selection and purchase is such that the "Additional rules" for selecting specified residential property(ies) applicable to Group A cannot be satisfied, then Group A will end.
 - (c) The Group B1 Selection will take place after the completion of the Group A Selection as determined by the Vendor at its discretion. The registrants under Group B1 shall proceed to select the specified residential property(ies) which are still available at the time of selection in the order of priority according to the balloting result priority.
 - (d) The Group B Selection will take place after the completion of the Group B1 Selection as determined by the Vendor at its discretion. The registrants under Group B shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the balloting result priority.

(e) Group A1, Group A, Group B1 and Group B

- (i) Where a registrant selects only one specified residential property in respect of a Registration of Intent, the purchaser(s) of that specified residential property shall only be:
 - (1) That registrant; or
 - (2) That registrant together with one or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s); or
 - (3) That company registrant.
- (ii) Where a registrant selects more than one specified residential property in respect of a Registration of Intent:
 - (1) The purchaser(s) of at least one so selected specified residential property shall only be:
 - I. That registrant; or
 - II. That registrant together with one or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s); or
 - III. That company registrant; and
 - (2) The purchaser(s) of each other so selected specified residential property shall only be:
 - I. That registrant (or any individual constituting that registrant); or
 - II. One or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to be the purchaser(s); or
 - III. That registrant (or any individual constituting that registrant) together with one or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s); or
 - IV. That company registrant; or
 - V. A company which is incorporated in Hong Kong and any one director of which must be the same person as any one director of that company registrant.

- (iii) "Immediate Family Member" of Group A1, Group A, Group B1 and Group B registrant means a spouse, parent, child, sibling, grandparent or grandchild of that registrant. Purchasers have to bring along with the relevant valid supporting document(s) as a proof to the satisfaction of the Vendor.
- (iv) The company registrant have to bring along with the relevant valid supporting document(s) as a proof of a company which is incorporated in Hong Kong and any one director of which must be the same person as any one director of that company registrant to the satisfaction of the Vendor.
- (v) The Vendor reserves its absolute right to determine whether or not a participant is a qualified "Immediate Family Members" and a company which is incorporated in Hong Kong and any one director of which must be the same person as any one director of that company registrant.
- 8. Card(s) or Passport(s) of the registrant (or a copy of the I.D Card(s) or Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person), the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the I.D Card or Passport of the authorized person.

First-come-first-served

After the completion of the balloting and the selecting and purchasing of the specified residential properties by the eligible persons in accordance with the above procedures, the order of priority in the selection of all the remaining specified residential properties (if any) will be on a first-come-first-served basis. The order of priority in the selection of the remaining specified residential properties including C-3/F, C-5/F, C-8/F, C-9/F in Tower 3A (if still available) will be on a first-come-first-served basis. Persons interested in purchasing must personally attend the designated place where the sale will take place to purchase the remaining specified residential properties. For the purpose of maintaining order at the designated place, the Vendor reserves the right to allocate a particular specified residential property to a particular interested person and determine to whom a residential property will be sold by any method (including balloting) in case of any dispute.
