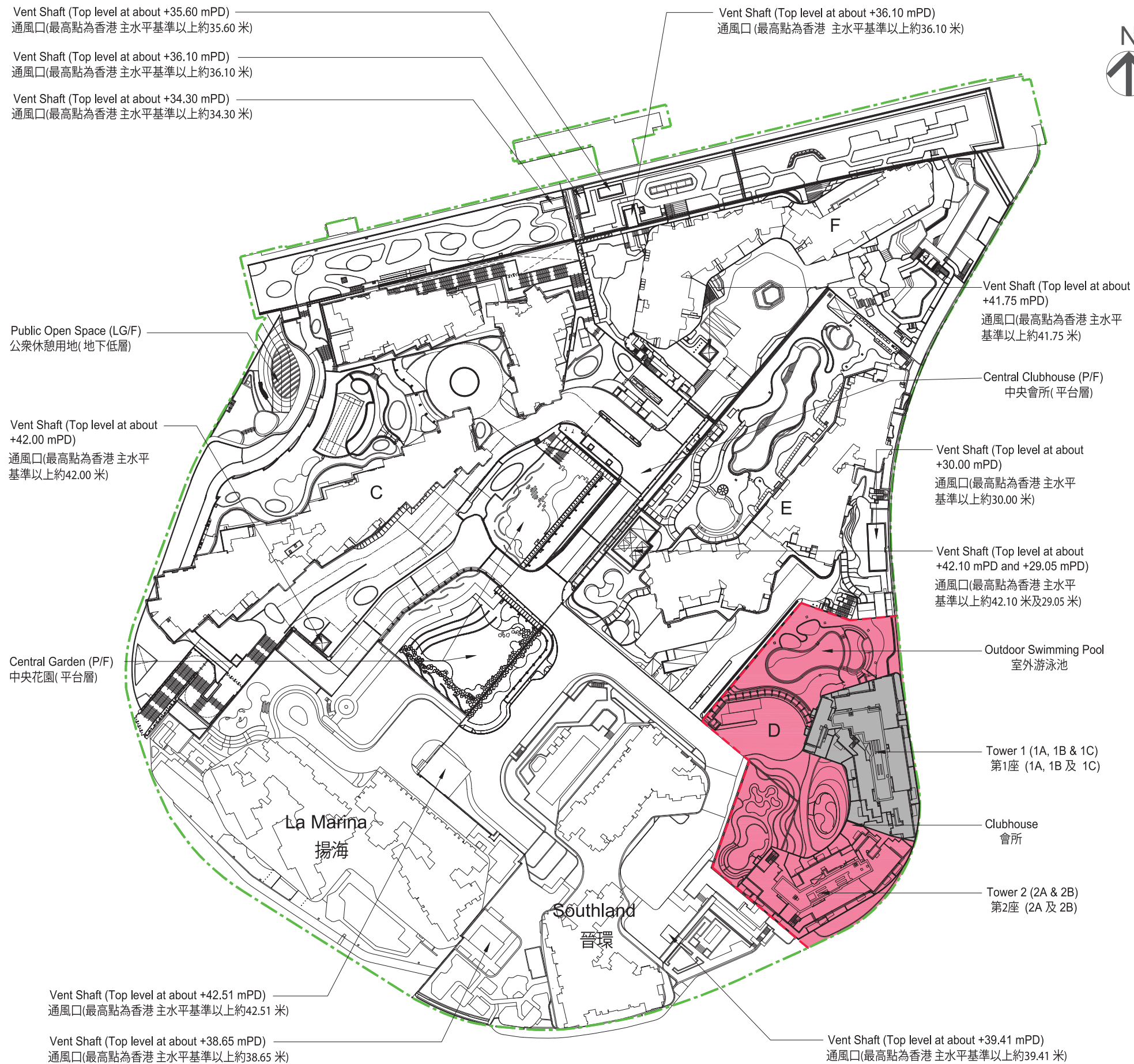


10 發展項目的布局圖 LAYOUT PLAN OF THE DEVELOPMENT

- C. 位於E地盤的發展項目第5期的認可人士提供該期數的預計落成日期為2026年9月2日。
- D. 位於F地盤的發展項目第6期的認可人士提供該期數的預計落成日期為2028年2月3日。

- A. The estimated date of completion of Phase 3B of the Development located in Site C is 15 December 2024 as provided by the Authorized Person for the said phase. The estimated date of completion of Phase 3C of the Development located in Site C is 15 March 2025 as provided by the Authorized Person for the said phase.
- B. The estimated date of completion of the Phase (coloured pink on the plan) located in Site D is 30 November 2024 as provided by the Authorized Person for the said phase. The estimated date of completion of Phase 4B (coloured grey on the plan) of the Development located in Site D is 30 November 2024 as provided by the Authorized Person for the said phase.
- C. The estimated date of completion of Phase 5 of the Development located in Site E is 2 September 2026 as provided by the Authorized Person for the said phase.
- D. The estimated date of completion of Phase 6 of the Development located in Site F is 3 February 2028 as provided by the Authorized Person for the said phase.
