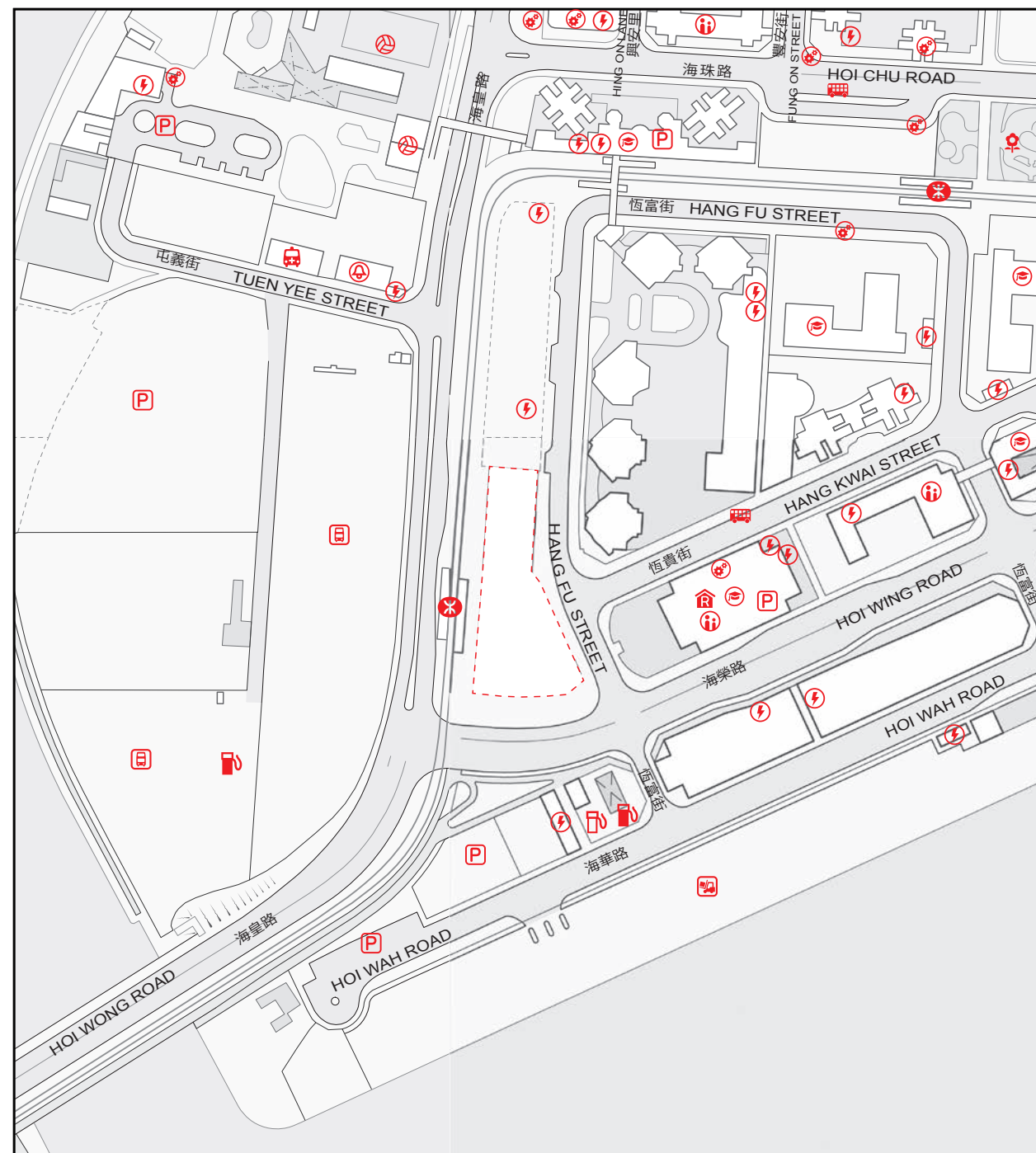


LOCATION PLAN OF THE DEVELOPMENT 發展項目的所在位置圖
