















第3座 立面圖 TOWER 3 - ELEVATION PLAN










立面圖 2 ELEVATION PLAN 2






第3座 立面圖 TOWER 3 - ELEVATION PLAN








立面圖 4 ELEVATION PLAN 4






第5座 立面圖 TOWER 5 - ELEVATION PLAN




第5座 立面圖 TOWER 5 - ELEVATION PLAN
