Section (I) – Abstract

Section (II) – Submission of Registration of Intent

2. ~~A registrant (if the registrant is a corporation, then **all of its directors**) must **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) submit the following:~~

(a) ~~only one Registration of Intent duly completed and signed by the registrant;~~

(b) ~~the Registration of Intent shall be accompanied with cashier order(s) each in the sum of HK\$50,000 and made payable to “**WOO KWAN LEE & LO**”. The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent;~~

3. ~~For the avoidance of doubt, all valid Registrations of Intent previously submitted to the Vendor at or before 12:00 noon on 5 October 2022 under any other Sales Arrangements are hereby declared invalid and will **not** be applicable in this Sales Arrangements and will not be included in the balloting.~~

Section (III) – Balloting

4. ~~Balloting will be used to determine the order of priority in selecting the specified residential properties.~~

5. ~~The first round balloting will be carried out on 20 January 2023 at or after 1:00 p.m. to divide the registrants into one or more group(s). For the purposes of maintaining order at the ICC Venue, the second round balloting to determine each registrant’s “ballot result sequence” may either take place in batches at the ICC Venue (at the Time of the Sale on the First Day of Sale or on 20 January 2023 at or after 1:00 p.m. after completion of the first round balloting, to be decided in the Vendor’s absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the website designated by the Vendor for the Phase (www.wetlandseasonsbay3.com.hk) (the “Designated Website”) after 1:30 p.m. on 20 January 2023. Registrants will not be separately notified.~~

6. ~~The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth balloting and/or due to the reasons set out in paragraph 23 below, to adjust the date, time and location of the balloting. Any changes to the date, time and location of the balloting will be posted at the ICC Venue and at the ICC Lobby. Registrants will not be notified separately of such changes.~~

Section (V) – General Provisions

16. The following apply to registration:-

- (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration will not be accepted.
- (b) The Registration of Intent is personal to the registrant and shall not be transferable.
- (c) The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties.
- (d) (For corporate registrant) If after the submission of Registration of Intent, there is any change in the composition of the board of directors of the corporation, then the relevant Registration of Intent shall become invalid immediately and the registrant **shall not be eligible to participate in the selection and purchase of specified residential properties.**
- (e) In case of dispute, the Vendor reserves its right to determine whether a registrant is eligible to participate in the selection and purchase of specified residential properties and whether a Registration of Intent is valid and should be included in balloting.

17. Arrangements on cashier order(s):-

- (a) The cashier order(s) submitted will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
