Subject to other matters, **sale by tender**. Different tender sales will be carried out on different Dates of the Sale. Each tender sale is conducted independently on each Date of the Sale. Potential buyers must submit a new tender for each Date of the Sale they wish to be considered. Tenders from previous Date of the Sale are not automatically carried over to subsequent Date of the Sale. Please see Schedule for details. The vendor reserves the absolute right to accept or reject any tender at its sole discretion. Please refer to the tender documents for details. The tender documents of the specified residential property(ies) will be made available for collection free of charge at the Sales Office between 5 p.m. and 5:30 p.m. from 15 September 2025 daily until the closing time of the closing date of the tender.

Although a specified residential property may be available for tender on a Date of the Sale, it may become unavailable during that Date of the Sale because the Vendor may accept a previous tender for that specified residential property after the close of such previous tender exercise. In such event, the Vendor will reject other offer(s) for that specified residential property.

2. The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender from time to time by amending the Sales Arrangements.

Please note also that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
