The tender documents of the specified residential property(ies) will be made available for collection free of charge at the Sales Office between 5 p.m. and 5:30 p.m. from 5 October 2025 daily until the closing time of the closing date of the tender.

In such event, the Vendor will reject other offer(s) for that specified residential property.
