The first balloting will take place on 26 March 2024 in order to divide all registrants into sub-groups. The ballot results, including “registration number”, “sub-group number” and “sub-group check-in timeslot” shall be posted at the 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 11:00 p.m. on 26 March 2024. The sub-group with the earliest “sub-group check-in timeslot” will include one or more Registrations of Intent(s) submitted by each registrant. The registrant(s) will not be separately notified of the ballot results. The Vendor shall not be responsible to the registrants for any error or omission contained the ballot procedure and/or results.
