Balloting in the manner as described below will be used to determine the order of priority for selection of specified residential properties. 揀選指明住宅物業的優先次序將以下列抽籤方式決定。2. Individuals interested in purchasing any specified residential property(ies) (referred to below as “Registrant(s)”) shall submit Registration of Intent during the specified period. Each individual Registrant (whether in his/her/its own name or in joint names with any other party(ies)) shall submit only ONE (1) Registrations of Intent. Any excess Registration of Intent will not be accepted. A Registrant shall not include both company(ies) and individual(s). 有意購買任何指明住宅物業的個人(於下文稱為「登記人」)須於指定時間內遞交購樓意向登記。每個登記人(無論以自己名義或與他方聯名)只可以遞交一份購樓意向登記。超出數目的購樓意向登記將不會被接納。登記人不可同時由公司及個人組成。3. Registrants shall attend Shop 4, G/F, Allegro, No. 138 Carpenter Road, Kowloon City in person to submit the Registration of Intent together with cashier’s order(s) (in the amount of HK\$100,000 and made payable to “Mayer Brown”) and copy(ies) of identification document(s). After successful submission of the Registration of Intent and other required documents at Shop 4, G/F, Allegro, No. 138 Carpenter Road, Kowloon City, the Registrants will receive official receipt(s) for the Registration of Intent. 登記人須親臨前往九龍城賈炳達道 138 號瓏碧地下 4 號舖遞交購樓意向登記連同銀行本票(金額為港幣 \$100,000。銀行本票抬頭人為「孖士打律師行」)及身份證明文件副本。登記人於九龍城賈炳達道 138 號瓏碧地下 4 號舖完成遞交購樓意向登記及其他所需文件後，將會收到購樓意向登記正式收據。	

5. The identification document(s) required are copy(ies) of the H.K.I.D. Card(s) or Passport(s) (as the case may be) of (each of) the Registrant(s).

6. The submission of the Registration of Intent has started. The deadline of submission of the Registration of Intent is 6:00 p.m., 6 March 2024. Late submission will not be accepted. Please note that the completion of the verification of a Registrant's identity, any order of priority in respect of the selection of specified residential properties according to the balloting result, or the Vendor's admittance of any person to the waiting queue do not guarantee that Registrant will be able to purchase any specified residential property.

Part (III) : Balloting and selection of specified residential properties

10. Balloting will be adopted to determine the order of priority in the selection and purchase of the specified residential properties by the Registrant(s) on the First Date of Sale. Registrant(s) will not be separately notified of the ballot results.

11. Balloting will take place on or before 6:00 p.m. on 7 March 2024. The ballot results, including "registration number", "ballot result sequence" and "the check-in timeslot for Registrants" will be posted at Shop 4, G/F, Allegro, No. 138 Carpenter Road, Kowloon City (the "Sales Office") at about 7:00 p.m. on 7 March 2024. Registrant(s) will not be separately notified of the ballot results.

12. Any changes to the time or venue of Unit Selection will be announced at the Sales Office. Registrants will not be notified separately of any such changes.

In such event, such Registrant will not be eligible to select and purchase any specified residential properties on the First Date of Sale.

After the completion of selection and purchase of the specified residential properties by the eligible persons in accordance with the above procedures, the order of priority in the selection of all the remaining specified residential properties (if any) will be on a first-come-first-served basis. For the purpose of maintaining order at the place where the sale will take place, the Vendor reserves

the right to allocate a particular specified residential property to a particular interested person and determine to whom a particular specified residential property will be sold by any method (including balloting) in case of any dispute.
