1. The specified residential properties will be sold at the Sales Office on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting). The Vendor's decision shall be final and conclusive.
