- (a) Prospective purchasers will be offered to view the selected specified residential properties, or comparable residential properties if it is not reasonably practicable for such specified residential properties to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.

- (c) If on any Date of Sale, (i) Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 11 a.m. and 6 p.m.; or (ii) where the Vendor considers that there being an event affecting the safety, order or public health in the Sales Office and/or the vicinity, the Vendor reserves its absolute right to change, postpone, extend or modify the date, time, period and/or place of the sale of specified residential properties to such other date, time, period and/or place as the Vendor may consider appropriate. Details of the arrangement will be posted by the Vendor on the designated website of the Phase of the Development < www.beaconpeak.hk >. Persons interested in purchasing the specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
