- (a) The sale of the specified residential properties is subject to availability. Please note that the completion of the confirmation and verification of any order of priority in respect of the selection of the specified residential properties, or the Vendor's admittance of any person to the place where the sale will take place or the waiting queue thereof, does not guarantee that that person will be able to purchase any specified residential property.
