Any interested person must bring along his/her/their H.K.I.D. Card(s) or Passport(s), or in case of a Company, must bring along a copy of Business Registration Certificate and Registers of Directors, the director's H.K.I.D. Card(s) or Passport(s) and the company chop as well as blank cheque(s) for payment of balance of preliminary deposit(s).</li> <li>3.
