- (b) Session A Registrants are welcome to view the balloting.
- (c) For the purposes of balloting, every Registration of Intent\* shall be allotted such number of registration number(s) which equals to the number of specified residential property(ies) which the Session A Registrant intends to purchase as indicated in the relevant Registration of Intent\*.

On 13 March 2021 (the "First Date of Sale"):

- 3. Session A Registrant must bring along his/her/their H.K.I.D. Card(s) or Passport(s) and the official receipt of the Registration of Intent\* bearing the “registration number”.
- 4. Session A Registrant whose identities have been confirmed and verified by the Vendor shall be eligible to personally select the specified residential properties which are still available at the time of selection in the order of priority according to the “balloting result priority” and in an orderly manner and within reasonable time.
- 5. Any Session A Registrant who arrives at the Sales Office at any time later than the “attending time slot for Session A Registrants” shall not be eligible to select any specified residential properties.

In relation to the purchase of the first specified residential property as listed above by a Session A Registrant, a Session A Registrant may submit a Declaration of Relationship together with the Registration of Intent\*, such that the Related Party(ies)# stated in such Declaration of Relationship can purchase such specified residential property, subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.
12. In relation to the purchase of the second or more (if applicable) specified residential property(ies) as listed above by a Session A Registrant, a Related Party(ies)# of such Session A Registrant may purchase such specified residential property(ies) subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.
13. If a Session A Registrant who has selected any one or more specified residential property(ies) in respect of a Registration of Intent\* according to the ballot result priority on the First Date of Sale, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said Session A Registrant has given up the right to select and purchase any specified residential property(ies) during the relevant time for unit selection in respect of that Registration of Intent\*.
