### Batch 1

The sale of the specified residential properties will be divided into 2 sessions, and shall be proceeded in the following order, namely, Session A followed by Session B:-

### Procedures for Session A

On 17 March 2021 (the "First Date of Sale"):

1. Eligible persons interested in purchasing any of the specified residential properties that will be offered to be sold in Session A and who had submitted the Registration of Intent (Please note below “Other Matters for Batch 1”)(“Session A Registrant”) must follow the rules as set out in this section.
2. The order of priority for selection of the specified residential properties in Session A will be determined by balloting.
3. On the First Date of Sale, a Registrant who holds a valid Registration of Intent\* (if the Registrant is a company, then any one of its directors) shall personally attend the Sales Office between 10:00 a.m. and 10:30 a.m..
4. Registrants must bring along his/her/their H.K.I.D. Card(s) or Passport(s) and the official receipt of the Registration of Intent\* bearing the “registration number”. Company Registrants must also bring along a copy of Business Registration Certificate and Registers of Directors, the director’s H.K.I.D. Card(s) or Passport(s) and the company chop.
5. Registrants whose identities have been confirmed and verified by the Vendor shall be eligible to personally select the specified residential properties which are still available at the time of selection in the order of priority according to the “balloting result priority” and in an orderly manner and within reasonable time.
6. For the purposes of balloting, every Registration of Intent\* shall be allotted such number of registration number(s) which equals to the number of specified residential property(ies) which the Registrant intends to purchase as indicated in the relevant Registration of Intent\*.
7. Any Registrant who arrives at the Sales Office at any time later than 10:30 a.m. on the First Date of Sale shall not be eligible to select any specified residential properties.
8. The balloting will take place at the Sales Office at 10:45 a.m. on the First Date of Sale. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth operation of the balloting procedures, to adjust the time, date and location of the balloting. Registrants will not be notified separately of such changes.
9. The balloting results, including “registration number” and “balloting result priority” will be posted at the Sales Office after the balloting. Registrants will not be separately notified of the balloting results.



10. If there are more than one registration number allotted to a Registration of Intent\*, the registration number allotted with a lower priority shall be automatically cancelled and be treated as null and void.
11. Registrant who leaves the Sales Office during his/her/their session(s) for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties and his/her/their order of priority shall lapse immediately.
12. Each Session A Registrant shall be entitled to purchase the specified residential properties which are still available for the Session A Registrant at the time of selection in accordance with the abovesaid rules. Please bring along blank cheque(s) for payment of balance of preliminary deposit(s).
13. In avoidance of doubt, if an intention to purchase more than one specified residential properties has been indicated in a Registration of Intent\* and one or more Preliminary Agreement(s) for Sale and Purchase has/have been entered into for such number of specified residential properties with respect to such Registration of Intent\*, the “registration number(s) allotted with a later position” allocated thereto and referred to in paragraph 10 above shall immediately lapse.
14. Subject to paragraph 10, 11 and 12 above, if the Session A Registrant has successfully selected any specified residential property(ies), the Session A Registrant and/or his/her/their Related Party(ies)# shall personally enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected specified residential property(ies).
15. Before signing the Preliminary Agreement for Sale and Purchase, the Session A Registrant may request the Vendor on spot to add name(s) of individual(s) provided that all the individual(s) comprised in the Registration of Intent\* must be direct family member(s) (i.e. spouse, parents and children) of each other and all individual(s) signing the Preliminary Agreement for Sale and Purchase must be the direct family member(s) of each other and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final. The Vendor reserves its absolute discretion to allow or refuse the request to omit/add any names of any individual(s) in the Preliminary Agreement for Sale and Purchase.
16. In relation to the purchase of the first specified residential property as listed above by a Session A Registrant, a Session A Registrant may submit a Declaration of Relationship together with the Registration of Intent\*, such that the Related Party(ies)# stated in such Declaration of Relationship can purchase such specified residential property, subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final.

17. In relation to the purchase of the second or more (if applicable) specified residential property(ies) as listed above by a Session A Registrant, a Related Party(ies)# of such Session A Registrant may purchase such specified residential property(ies) subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.
18. If a Session A Registrant who has selected any one or more specified residential property(ies) in respect of a Registration of Intent\* according to the ballot result priority on the First Date of Sale, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said Session A Registrant has given up the right to select and purchase any specified residential property(ies) during the relevant time for unit selection in respect of that Registration of Intent\*. In such event, such Session A Registrant will not be eligible to select any of the specified residential properties in the relevant time for unit selection on the First Date of Sale in respect of that Registration of Intent\*.
19. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).
20. The Vendor also reserves its right to revise the time of balloting, posting ballot results and selecting specified residential properties depending on the progress of confirmation and verification of identities of Session A Registrants or other necessary procedures.
21. The Vendor reserves the right to close the Sales Office at any time if all the specified residential properties have been sold out. For the safety of Session A Registrants and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in force in Hong Kong, postpone, extend and/or modify the date, time, period, deadline and/or place of any balloting, attending timeslot for Session A Registrants and/or selection of specified residential properties to such other date, time, period, deadline and/or place as the Vendor may consider appropriate. 23. The order of priority for selection of the specified residential properties in Session B will be determined by balloting.
24. On the First Date of Sale, a Registrant who holds a valid Registration of Intent\* (if the Registrant is a company, then any one of its directors) shall personally attend the Sales Office between 10:00 a.m. and 10:30 a.m..
25. Registrants must bring along his/her/their H.K.I.D. Card(s) or Passport(s) and the official receipt of the Registration of Intent\* bearing the “registration number”. Company Registrants must also bring along a copy of Business Registration Certificate and Registers of Directors, the director’s H.K.I.D. Card(s) or Passport(s) and the company chop.
26. Registrants whose identities have been confirmed and verified by the Vendor shall be eligible to personally select the specified residential properties which are still available at the time of selection in the order of priority according to the “balloting result priority” and in an orderly manner and within reasonable time.
27. For the purposes of balloting, every Registration of Intent\* shall be allotted such number of registration number(s) which equals to the number of specified residential property(ies) which the Registrant intends to purchase as indicated in the relevant Registration of Intent\*.

31. If there are more than one registration number allotted to a Registration of Intent\*, the registration number allotted with a lower priority shall be automatically cancelled and be treated as null and void.
32. 35. Subject to paragraph 26 above, after successful section of one or more specified residential property(ies), Session B Registrant must sign such one or more Preliminary Agreement of Sale and Purchase in person.
36. Before signing the Preliminary Agreement for Sale and Purchase, the Session B Registrant may request the Vendor on spot to add name(s) of individual(s) provided that all the individual(s) comprised in the Registration of Intent\* must be direct family member(s) (i.e. spouse, parents and children) of each other and the additional individual(s) must be the direct family member(s) of ALL the individual(s) comprised in the Registration of Intent\* and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final. The Vendor reserves its absolute discretion to allow or refuse the request of the Session B Registrant to add any name(s) of individual(s).
37. If a Session B Registrant who has selected any one or more specified residential property(ies) in respect of a Registration of Intent\* according to the ballot result priority on the First Date of Sale, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said Session B Registrant has given up the right to select and purchase any specified residential property(ies) during the relevant time for unit selection in respect of that Registration of Intent\*. In such event, such Session B Registrant will not be eligible to select any of the specified residential properties in the relevant time for unit selection on the First Date of Sale in respect of that Registration of Intent\*.
38. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

39. The Vendor also reserves its right to revise the time of balloting, posting ballot results and selecting specified residential properties depending on the progress of confirmation and verification of identities of Session B Registrants or other necessary procedures.

40. The Vendor reserves the right to close the Sales Office at any time if all the specified residential properties have been sold out. For the safety of Session B Registrants and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in force in Hong Kong, postpone, extend and/or modify the date, time, period, deadline and/or place of any balloting, attending timeslot for Session B Registrants and/or selection of specified residential properties to such other date, time, period, deadline and/or place as the Vendor may consider appropriate.
