#### (II) Procedures for Session B

- 1. Eligible persons interested in purchasing any of the specified residential properties that will be offered to be sold in Session B ("Form B Registrant") must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (III) of this Sales Arrangements.
- 2. Form B Registrant must submit the following:-
  - (a) only one Registration of Intent (Form B) duly completed and signed by the Form B Registrant;
  - (b) Registration of Intent (Form B) shall be accompanied with cashier order(s).
