Any person interested in purchasing any of the specified residential properties ("<b>Prospective Purchaser</b>") (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> <li>(a) personally attend the WTC Venue; and</li> <li>(b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <u>Prospective Purchaser</u>. Each cashier order shall be in the sum of HK\$100,000 and made payable to "<b>MAYER BROWN</b>".</li> </ol> </li> <li>2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the WTC Venue before the commencement time of sale.</li> <li>3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).</li> <li>4. 1. 先到先得。何有意購買指明住宅物業的人士（下稱「**準買方**」）（如準買方是公司，則其任何一位董事）須遵從下列程序：

  2. 為決定優先次序的目的，賣方不接受出售時間開始前於 WTC 會場排隊輪候的人士。
