3.1 Based on the selection made under the Registration(s) of Intent by the registrant(s) (“**Registrant(s)**”), each Registration of Intent may be used for showing of interest to purchase either:-

- (i). more than 1 specified residential property (the Registration of Intent of this type is referred to as “**Group A Registration of Intent**”); or
- (ii). 1 specified residential property (the Registration of Intent of this type is referred to as “**Group B Registration of Intent**”) (please note that a company Registrant can only purchase 1 specified residential property and its Registration of Intent shall be classified as a Group B Registration of Intent)

subject to the rules set out in paragraph 1.1 above.

3.2. No more than 1 Group A Registration of Intent can be submitted by each individual registrant, in sole name or in joint names with other individual(s) as a Registrant.

Group A Registration of Intent submitted by a company Registrant will not be accepted. Company Registrant (comprising not more than 1 company registrant), which must be a company incorporated in Hong Kong, can submit only 1 Group B Registration of Intent.

If an individual registrant did not submit a Group A Registration of Intent, such individual registrant can submit 2 Group B Registrations of Intent, in sole name or in joint names with other individual Registrant(s) as a Registrant.

If an individual registrant has submitted a Group A Registration of Intent, such individual registrant cannot submit more than 1 Group B Registration of Intent, in sole name or in joint names with other registrant(s) as a Registrant.

For the purpose of this paragraph 3.2: (i) for Registrant comprising 2 or more individual registrants under a Group A Registration of Intent, each of such individual registrants shall be regarded as having submitted a Group A Registration of Intent; and (ii) for Registrant comprising 2 or more individual registrants under a Group B Registration of Intent, each of such individual registrants shall be regarded as having submitted a Group B Registration of Intent.

Registrant(s) submitting a Group A Registration of Intent shall purchase more than 1 specified residential property by using such Group A Registration of Intent submitted, otherwise, such Group A Registration of Intent shall become void and the right of purchase thereunder shall become invalid.

Registrant(s) submitting a Group B Registration of Intent shall only and must purchase 1 specified residential property, otherwise, such Group B Registration of Intent shall become void and the right

of purchase thereunder shall become invalid.

Company Registrant submitting a Group B Registration of Intent shall only purchase not more than 1 specified residential property.

- 3.3 Each Group A Registration of Intent shall be submitted together with 2 cashiers' orders, each in the sum of HK\$100,000 made payable to "Baker & McKenzie". Each Group B Registration of Intent shall be submitted together with 1 cashier's order in the sum of HK\$100,000 made payable to "Baker & McKenzie".

- 3.4 Higher priority of selection of specified residential properties will be given to Group A Registrations of Intent in accordance with the provisions in paragraph 4 below. Balloting will be used to determine the order of priority of selection of specified residential properties amongst Group A Registrations of Intent as a separate group in accordance with the provisions in paragraph 4.1 below. Balloting will be used to determine the order of priority of selection of specified residential property of Group B Registrations of Intent as another separate group in a lower priority than Group A Registrations of Intent.

4.1 Applicable to Registrants of Group A Registration of Intent (“Group A Registrants”)

- (i). The balloting to determine the priority of Group A Registration of Intent for the selection of specified residential properties will take place first on the First Date of Sale at the Designated Venue. The Vendor will post and announce the Attendance Registration Period of Group A Registration of Intent on the day before the First Date of Sale at or after 4:00 p.m. at the Ground Floor of the Designated Venue. The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting and/or Attendance Registration Period. Any changes to the time and date of the balloting and/or Attendance Registration Period will be posted on the Ground Floor of the Designated Venue and announced on the Development Website at [www.ksummit.com.hk](http://www.ksummit.com.hk) (“Development Website”). Registrants will not be notified separately of such changes.

- (ii). In the first round balloting, each Group B Registration of Intent will be allotted with one lot.

Any changes to the time and date of the first round balloting, the second round balloting and/or Attendance Registration Period(s) mentioned above will be posted on the Ground Floor of the Designated Venue and announced on the Development Website. Registrants will not be notified separately of such changes.

Registrants who fail to register during the applicable Attendance Registration Period shall not be eligible for selection of specified residential properties.

If the Group A Registrant purchases more than two specified residential properties, in respect of two of the specified residential properties so purchased, the preliminary deposit thereof shall be paid as aforesaid whereas in respect of each of the remaining specified residential property(ies) so purchased, the Registrant shall on spot submit to the Vendor additional cashier’s order(s) in the aggregate sum of HK\$200,000 made

payable to “Baker & McKenzie” for payment of part of preliminary deposit thereof (the remaining balance of preliminary deposit shall be paid by cheque(s) and/or cashier’s order(s)).

如A組登記人最終購買2個指明住宅物業，A組登記人就每一個購買的指明住宅物業，須即場向賣方遞交額外一張或多張本票，總金額為港幣\$100,000，抬頭人為「貝克·麥堅時律師事務所」或“Baker & McKenzie”以支付臨時訂金的部份餘額（臨時訂金餘款以支票及／或銀行本票支付）。如A組登記人購買的指明住宅物業多於兩個，就其中2個所購買的指明住宅物業，臨時訂金須以上述方式支付，而就每一個其餘之所購買的指明住宅物業，A組登記人須即場向賣方遞交額外一張或多張本票，總金額為港幣\$200,000，抬頭人為「貝克·麥堅時律師事務所」或“Baker & McKenzie”以支付部份臨時訂金（臨時訂金餘款以支票及／或銀行本票支付）。

If an individual registrant of a Group B Registration of Intent purchases 1 specified residential property, before entering into the preliminary agreement for sale and purchase in respect of such specified residential property (“PASP”), such registrant of Group B Registration of Intent may request the Vendor on spot to add one or more relative(s) of any individual comprising that registrant in such Group B Registration of Intent as joint purchaser(s) provided that the relevant supporting documents must be provided to the satisfaction of the Vendor to prove the relationship(s) with such relative(s).

- (i) the purchaser of at least one of such specified residential properties so purchased shall be that Group A Registrant who may request the Vendor on spot to add one or more relative(s) of any individual comprising such Group A Registrant as joint purchaser(s) provided that the relevant supporting documents must be provided to the satisfaction of the Vendor to prove the relationship(s) with such relative(s).
- (ii) in respect of each other specified residential property so purchased, such Group A Registrant may request the Vendor on spot to:
  - a. add one or more relative(s) of any individual comprising such Group A Registrant as joint purchaser(s); or
  - b. put one or more relative(s) of any individual comprising such Group A Registrant as the purchaser(s) in the PASP(s), and omit the name(s) of any individual comprising such Group A Registrant from the PASP(s) as purchaser(s).

provided that the relevant supporting documents must be provided to the satisfaction of the Vendor to prove the relationship(s) with such relative(s).

如一A組登記人購買2個或以上指明住宅物業:

- 5.7. “Relative” means a spouse, parent, child, child-in-law, brother, sister, grandparent, grandchild, parent of spouse, uncle, aunt, nephew or niece, of the Registrant or the individual comprising that Registrant. 「親屬」一詞是指登記人或組成該登記人的個人登記者之配偶、父母、子女、媳婦、女婿、兄弟姊妹、祖父母或外祖父母、孫、孫女、外孫、外孫女、配偶之父或母、伯

父母、叔父母、舅父母、姑丈、姑母、姨丈、姨母、姪、姪女、姨甥、姨甥女。

6. Notwithstanding anything herein contained, the following provisions apply to the selection of specified residential properties on the First Date of Sale: When it is the turn for a Group B Registrant to select a specified residential property in respect of a Group B Registration of Intent, that Group B Registrant (the “**Registrant Concerned**”) may, in addition to making that selection, opt for having the selection of specified residential property in respect of a Qualified Registration of Intent of that Group B Registration of Intent with a lower priority to be made at the same time. “Qualified Registration of Intent” means any other Group B Registration of Intent if the Registrant under that other Group B Registration of Intent or any person constituting that Registrant is the Registrant Concerned or any person constituting the Registrant Concerned. For the avoidance of doubt: (i) only specified residential property(ies) available for selecting may be selected; (ii) the purchaser(s) of any additionally selected specified residential property(ies) shall be the Registrant of the relevant Qualified Registration of Intent, subject to paragraph 5.5 above; and (iii) the above provisions does not apply to any Group A Registrant.

The Vendor reserves the right to return any unused cashier's order(s) in such other manner as the Vendor considers appropriate.
