All specified residential properties will be available for selection and purchase from 12:00 noon on the first date of sale at 8 Observatory Road Venue on a first come first served basis to any person interested in purchasing the specified residential properties.

A person interested in purchasing the specified residential properties shall submit the following to the Vendor at the Sales Office:
