Any person interested in purchasing any of the specified residential properties (“<b>Prospective Purchaser</b>”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> <li>(a) personally attend the KENNEDY 38 Venue; and</li> <li>(b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <u>Prospective Purchaser</u>. Each cashier order shall be in the sum of HK\$100,000 and made payable to “<b>MAYER BROWN</b>”.</li> </ol> </li> <li>2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the KENNEDY 38 Venue before the commencement time of sale.</li> <li>3.
