First come first served. Any person interested in purchasing any of the specified residential properties (“Prospective Purchaser”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> (a) personally attend the KENNEDY 38 Venue; and (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <u>Prospective Purchaser</u>. Each cashier order shall be in the sum of HK\$100,000 and made payable to “MAYER BROWN”. 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the KENNEDY 38 Venue before the commencement time of sale. 3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting). 4. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall personally enter into one or more Preliminary Agreement(s) for Sale and Purchase of the specified residential property(ies) successfully selected by him/her/it. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies). 5. The Vendor reserves the right to close the KENNEDY 38 Venue at any time if all the specified residential properties have been sold out.

If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 6:00 p.m. on any date of sale, for the safety of the Prospective Purchasers and the maintenance of order at the KENNEDY 38 Venue, the Vendor reserves its absolute right to close the KENNEDY 38 Venue. Prospective Purchasers will not be notified separately of the arrangement.
