## **Part (II) : Registration**

### **第(II)部分：登記**

5. Registrant shall submit a Registration of Intent electronically and online via <https://ors.ontolo.com.hk> (the “**registration website**”) and follow the procedures specified therein. The time and manner for the submission of the Registration of Intent and the documents and materials required, etc. are specified in the online Registration of Intent and the registration website.
