Batch 1

On 22 October 2021 (the "First Date of Sale"):

1. Subject to paragraph 3 below, an interested person who attends the Sales Office in person between 10:00 a.m. and 10:30 a.m. on the First Date of Sale (the "Attendance Registration Period") and expresses an interest to purchase a residential property will have the priority to purchase that residential property upon the expiry of the Attendance Registration Period.
2. Any interested person must bring along his/her/their H.K.I.D. Card(s) or Passport(s), or in case of a Company, must bring along a copy of Business Registration Certificate and Registers of Directors, the director's H.K.I.D. Card(s) or Passport(s) and the company chop as well as blank cheque(s) for payment of balance of preliminary deposit(s).
3. If during the Attendance Registration Period, more than one person attends the Sales Office in person and express the interest to purchase the same residential property, balloting will be used to determine the order of priority in which each of such persons may purchase that residential property.
4. Upon the expiry of the Attendance Registration Period, each interested person shall proceed to select and purchase the specified residential property(ies) that he/she has expressed interest to purchase in the order of priority as determined by paragraphs 1 and 3 above within reasonable time and in an orderly manner, otherwise his/her order of priority shall lapse automatically.

5. After the selection of the residential properties as aforesaid, the remaining residential properties, if any, will be sold on a first come first served basis.
6. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).
