2. Person interested in purchasing must personally attend the Sales Office to select the specified residential property(ies) that the person wishes to purchase. The Vendor does not accept any person interested in purchasing having queued up before the time of the sale on any date of sale.

On a date of sale and subject to any arrangement of the Vendor from time to time, Prospective Purchasers will be offered and are advised by the Vendor to view the specified residential property(ies) which they intend to purchase before selection and purchase of any of the specified residential property(ies). In order to maintain order at the Sales Office and to ensure the smoothness of the selection procedures, after Prospective Purchasers have selected the specified residential property(ies), the Prospective Purchasers shall sign the preliminary agreement for sale and purchase of such specified residential property(ies) forthwith. All Prospective Purchasers are therefore advised to make prior arrangements and view the specified residential property(ies) before the selection of that specified residential property(ies).
