The sale of the specified residential properties will be divided into 2 groups (namely Group A and Group B). The persons or companies interested in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual (whether in his/her own name or in joint names with any other parties) or company (in its own name only) registrants can only participate in any **ONE** group. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

Registration(s) of Intent (whether in his/her own name or in joint names with other parties) submitted from the same registrant exceeding such maximum number(s) will not be accepted. A registrant shall not include both company(ies) and individual(s).

- (i) All Group A Registrants must **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend** the “Designated Venue” from 10:30 a.m. to 11 a.m. (“Group A Attendance Registration Period”) on the First Date of Sale. Group A Registrant(s) who arrives at the Designated Venue at any time after the Group A Attendance Registration Period shall not be eligible to participate in the balloting.

The balloting will be carried out after the selection of specified residential properties by Group A1 registrants having higher Indicated Nos., if any.

Balloting of Group A will take place at the Designated Venue after the categorization as aforesaid. The Vendor reserves the right at any time, for the purposes of maintaining order at the Designated Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and/or date of the Group A Balloting. Any changes to the time and/or date of the Group A Balloting will be announced at the Designated Venue. Registrants will not be notified separately of such changes.
