produce valid supporting document(s) to prove the relationship of each of such Relative with the purchaser to the satisfaction of the Vendor. The Vendor reserves the right and absolute discretion to determine whether or not an individual is a qualified "Relative" of a purchaser.

However, the Vendor, in order to maintain order at the Sales Office, reserves the right to allocate a particular specified residential property to any interested person and determine to whom a particular specified residential property will be sold in case of any dispute by any method (including balloting).
