Section (I) - Abstract

The specified residential properties set out in Batch I of this Sales Arrangements <u>and</u> the specified residential properties set out in the Phase 1 SA (collectively the "Specified Residential Properties") will be offered for sale in accordance with the same set of sales procedures under this Sales Arrangements. In this Sales Arrangements, "Phase 1 SA" shall mean the Sales Arrangements No. 5 for Phase 1 of Wetland Lot No. 33 Development (as the same may be revised from time to time).

Registrants will not be notified separately of such changes.
 - (ii) The results of the first round balloting, including "registration number", "division of group", "check-in timeslot for each group" will be posted by the Vendor at the ICC Venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Registrants will not be separately notified of the ballot results.

- 18. The following apply to registration:-
 - (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration will not be accepted.
 - (b) The Registration of Intent is personal to the registrant and shall not be transferable.
 - (c) The order of submission of the Registration of Intent and the order of registration to participate in Session A will not have any impact on the order of priority for selecting the Specified Residential Properties in Session A and Session B.
