Interested parties should note that entry of everyone into the place where the sale will take place will be subject to satisfactory check of normal body temperature on-site. Everyone who enters the place where the sale will take place is required to wear a self-provided satisfactory surgical face mask at all times while at the place where the sale will take place. No face mask will be provided by the Vendor on-site. The Vendor reserves the absolute right and discretion to determine whether a person's body temperature is "normal" or "satisfactory" and whether a person's surgical face mask is of "satisfactory" standard, and to deny entry of anyone who fails to meet the aforesaid requirements, which may render in a loss of that person's right to select any specified residential property.
