For the avoidance of doubt, all valid Registrations of Intent (if any) previously submitted to the Vendor prior to the first date of the sale will not be included in this balloting.</li> <li>2. Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties (“<b>the registrant</b>”) must follow the procedures below.</li> <li>3. Registration Slips will be distributed at the V Walk Venue on the first date of the sale from 11:00 a.m. to 11:15 a.m. (“<b>check-in timeslot</b>”). 10.
