Persons interested in purchasing any of the specified residential properties (“<b>the registrant</b>”) must follow the procedures below.</p> <ol style="list-style-type: none"><li>1. For the avoidance of doubt, all valid Registrations of Intent (if any) previously submitted to the Vendor prior to the first date of the sale will not be included in this balloting.</li><li>2. Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties (“<b>the registrant</b>”) must follow the procedures below.</li><li>3. Registration Slips will be distributed at the V Walk Venue on the first date of the sale from 11:00 a.m. to 11:15 a.m. (“<b>check-in timeslot</b>”). Registrant shall <b>personally</b> (or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend, or if the registrant is or comprises corporation, then all directors of that</li></ol>

corporation shall **personally** attend, the V Walk Venue and submit the following:-
