The Receivers have the absolute right to accept any tender at or before the closing date and time of the tender. The Receivers have the absolute right to withdraw from the sale of any specified residential property at any time before

the acceptance of any offer. The Receivers have the absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place from time to time by amending and/or issuing the Sales Arrangements.

Notwithstanding anything herein provided, (i) if typhoon signal No.8 or above is hoisted or black rainstorm warning is issued in Hong Kong at any time between 10 a.m. on the day on which the tender closing time falls and the tender closing time; or (ii) if the place where sale will take place is/are the subject of an isolation order issued under the Prevention and Control of Disease Ordinance (Cap. 599, Laws of Hong Kong) or its subsidiary legislation due to COVID-19, or is/are required to be closed for carrying out disinfecting procedure arising from the occurrence of a case of COVID-19 on the tender closing date, the closing time of the tender will automatically be postponed to 5 p.m. on the next day or the day on which such isolation order is no longer in force.
