The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <a href="Prospective Purchaser">Prospective Purchaser</a>. - 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the ICC Venue before the commencement time of sale.

- 4.   - (c) if a Prospective Purchaser wishes to delete any individual(s), then prior to deletion of any individual(s) all the individual(s) comprised in the Prospective Purchaser must be the **close family member(s)** (i.e. spouse, parents, children, brothers, sisters, grandparents and grandchildren) of each other and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.

The Vendor reserves its absolute discretion to allow or reject the Prospective Purchaser's request to add and/or delete any individual(s).

- 6. The Vendor shall have the right in its absolute discretion to refuse to offer any specified residential properties to be sold to any Prospective Purchaser if he/she/it/they fail(s) to observe and comply with the requirements in paragraphs 1 to 5 above.
- 7. The Vendor reserves the right to close the ICC Venue at any time if all the specified residential properties have been sold out.
- 8. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 6:00 p.m. on any date of sale, for the safety of the Prospective Purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to close the ICC Venue.
