- 1) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing date and time of the tender. The Vendor has the absolute right to change the closing date and time of the tender from time to time by amending the Information on Sales Arrangements.

賣方並不承諾亦無責任閱覽、考慮或接受認購任何指明住宅物業最高出價之要約或任何要約。賣方有絕對權利於接受任何要約前於任何時間撤回出售任何指明住宅物業。賣方有絕對權利於招標截止日期及時間或之前接受任何要約。賣方有絕對權利及酌情決定權透過修改銷售安排資料不時更改招標截止日期及時間。

- 2) The tender sale of a specified residential property is subject to availability. Where the Vendor has accepted the tender for a specified residential property, no tender sale of that specified residential property will be carried out on the subsequent date(s) of the sale. Persons interested in submitting tenders for the specified residential properties are reminded to read the latest register of transactions so as to ascertain whether a particular specified residential property is still available for tender on a date of sale.

- 3) In case a black rainstorm warning signal or a typhoon signal no. 8 or above is hoisted between 2:00 p.m. and 4:00 p.m. on the closing date of the tender, the closing date and time of the tender will be extended to 4:00 p.m. on the next business day on which no black rainstorm warning signal or typhoon signal no. 8 or above is hoisted between 2:00 p.m. and 4:00 p.m..

若黑色暴雨警告信號或八號或以上颱風信號在招標截止日期當天下午 2 時正至下午 4 時正期間發出，招標截止日期及時間將延至下一個在當天下午 2 時正至下午 4 時正期間沒有發出黑色暴雨警告信號或八號或以上颱風信號的工作天，招標截止時間為該工作天的下午 4 時正。

- 4) If on any date of the sale, (i) a black rainstorm warning signal or a typhoon signal no. 8 or above is hoisted in Hong Kong; or (ii) where the Vendor considers that there being an event affecting the safety or order in the Sales Office and/or its vicinity, or (iii) the Hong Kong Government has imposed any restriction or issued any order relating to Coronavirus Disease 2019 (“COVID-19”) and is enforcing the same which requires people in Hong Kong (except for exempted persons) to stay indoor (such as stay-at-home, movement control or lockdown order), then, for the safety of the prospective purchasers and the maintenance of order at the Sales Office, or for compliance with the said restriction or order relating to COVID-19, the Vendor reserves its absolute right to change or postpone the date of sale to such other date, time, period, and/or place as the Vendor may consider appropriate and/or to close the Sales Office or any part thereof. Details of the arrangement will be posted by the Vendor on the designated website of the Development OR at the entrance of the Sales Office. Prospective purchasers will not be separately notified of the same.

Persons interested in submitting tenders of the specified residential properties are therefore reminded and advised to make prior arrangements to view the Properties for Viewing prior to tender submission.
