Subject to and conditional upon the Purchaser's completion of the sale and purchase of the Property with the Vendor in accordance with and in compliance in all respects with the Preliminary Agreement and the subsequent Agreement to be entered into between the Purchaser and the Vendor and becoming the registered owner of the Property, the Vendor is prepared to, without prejudice to the Purchaser's right under the Agreement, at its own cost and as soon as reasonably practicable after its receipt of a written notice served by the Purchaser within <u>3 years</u> from the date of completion of the sale and purchase of the Property (the "**Time Limit**"), remedy any defects to the Property (fair wear and tear excepted) caused otherwise than by any act or neglect of the Purchaser or the Purchaser's agent, contractor or resident, occupier or visitor of the Property, provided that:

For the avoidance of doubt, the Vendor bears no liability to the Purchaser for any failure or delay to perform this obligation.
