The Vendor does not accept any person interested in purchasing having queued up before the office hours of the Sales Office or Sales Office 2 (as the case may be). In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).

Purchasers comprising different combination of individual(s) are not regarded as the same Purchaser.
- (c) Prospective purchaser which is company shall not be entitled to submit registration or purchase any of the specified residential properties listed in these Sales Arrangements.
