The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing time of the tender.

Notwithstanding the aforesaid, the Vendor reserves the absolute right and discretion to adjust the

arrangements applicable to any prospective tenderer for viewing the specified residential properties.
