- (1) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing time of the tender.

- (2) The specified residential properties are available for viewing by prospective tenderers by prior appointment and submission of cashier order(s) in the amount as specified by the Vendor. Prospective tenderers are invited and advised to view the specified residential properties before submission of tender offer. For details of the viewing arrangements, please refer to the "Arrangements for Viewing of Specified Residential Property(ies) or Comparable Property(ies)" applicable for this Sales Arrangements issued by the Vendor (as may be amended by the Vendor from time to time). - (3) In case a black rainstorm warning signal is issued or a typhoon signal no.8 or above is hoisted by the Hong Kong Observatory or an announcement on "extreme conditions" is made by the Government of Hong Kong and is still in effect after 1:00 p.m. on 11 June 2024 or after 4:00 p.m. on any closing date of the tender (save and except 11 June 2024), the closing date and time of the tender will be extended to (in the case where the closing date of the tender is 11 June 2024) 2:00 p.m. on the next working day or (in the case of other closing date of the tender) 5:00 p.m. on the next working day in respect of which no black rainstorm warning signal is issued or no typhoon signal no.8 or above is hoisted or no announcement on extreme conditions is made by the Government of Hong Kong.
若在2024年6月11日下午1時正後或任何招標截止日期(2024年6月11日除外)下午4時正後香港天文台發出黑色暴雨警告或八號或以上颱風信號或香港政府發出「極端」情況的公布及該警告或信號或公布仍然生效，截標日期及時間將延至下一工作日的(如果招標截止日期為2024年6月11日)下午2時或(如果是其他招標截止日期)下午5時(而當天亦沒有發出黑色暴雨警告或八號或以上颱風信號或極端情況的公布)。
- (4) Persons interested in submitting tenders of the specified residential properties are reminded to examine the latest register of transactions of the Phase so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential

property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the acceptance period after the close of that previous tender exercise.

- (5) The Vendor may from time to time impose public health and security related precautionary measures and crowd control at the V Walk Venue. Any person who fails to comply with such measures and the direction of the Vendor may be rejected from admitting to the V Walk Venue. Any person whose health condition fails to comply with the measures and requirements (if any) imposed by the Hong Kong SAR Government for the purposes of the fight against COVID-19 and public interest may also be rejected from admitting to the V Walk Venue.
