All legal documents of the Second Mortgage Loan shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/its own solicitors to act for him/her/it, and in such event, the Purchaser shall also bear his/her/its own solicitors' costs and disbursements relating to the Second Mortgage Loan.

The Purchaser is advised to enquire with the designated financing company about the terms and conditions and the details of the Second Mortgage Loan. The approval or disapproval of the Second Mortgage Loan and the terms and conditions thereof are subject to the final decision of the designated financing company and are not related to the Vendor. Irrespective of whether the Second Mortgage Loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the ASP.

Without prejudice to the Purchaser(s)' rights under the ASP, the Vendor is prepared to at its own cost and as soon as reasonably practicable after receipt of a written notice served by the Purchaser(s) within 1 year from the date of completion of sale and purchase of the Property as stipulated in the PASP and the ASP or the actual date of completion on which the assignment in respect of the Property is entered into, whichever is earlier (the “Time Limit”) remedy any defects (fair wear and tear excepted) to the residential property (excluding any plants or landscaping in or sold with the residential property (if any) or any fittings, finishes, appliances or chattels added, installed or built to or at the residential property after the completion of its sale and purchase) caused otherwise than by any act or neglect of any person. The First 1 Year Warranty Offer is subject to the

terms and conditions of the relevant transaction documents.

Subject to the terms and conditions of the relevant transaction documents (including without limitation that the Purchaser shall settle each part payment and the balance of the purchase price[^] according to the respective dates stipulated in the agreement for sale and purchase and complete the purchase of the specified residential property in accordance with the agreement for sale and purchase), the Vendor will directly pay the ad valorem stamp duty ("AVD") payable by the Purchaser in respect of the agreement for sale and purchase of the specified residential property to the Inland Revenue Department. The payment shall be the amount of AVD actually payable but subject to a cap at 3% of the purchase price. The excess amount of the AVD above the cap (if any) shall be borne and paid by the Purchaser. Where the Purchaser owns any other residential property in Hong Kong (the "original property") at the time of signing of the PASP and subsequently sells the original property after the completion of the purchase of the specified residential property and then he/she applies for a partial refund of AVD from the Stamp Office, the Purchaser is not required to pay any part of the partial refund to the Vendor.

The Vendor is not and will not be involved in any disputes between the Purchaser and the designated furniture company.
