The Vendor, its receiver(s) and/or its manager(s) have the absolute right to accept any offer at or before the closing time of the tender. The Vendor, its receiver(s) and/or its manager(s) have the absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending and/or issuing the Sales Arrangements.
