In case of any dispute, the Vendor reserves its absolute right to allocate the above residential property(ies) to any person interested in purchasing by any method (including balloting).

- (a) The sale of the specified residential properties in the Development is subject to availability. Also, the Vendor reserves the right to suspend sale or reduce the number of properties to be offered for sale at any time without further notice.

Details will be announced on the website of the Development and interested persons will not be separately notified of the same. The Vendor reserves the absolute right to reject any person to enter into the Sales Office and/or any designated venue. The Vendor's decision in this regard shall be final and binding on all persons.
