Card(s)/Passport(s) of the Authorized Representative(s). 2.4 After verification of the identities of Registrants by the Vendor, the selection of specified residential properties according to the relevant order of Round of Selection (namely the First Round of Selection to be followed by the Second Round of Selection, the Third Round of Selection, and then the Fourth Round of Selection) will be proceeded in the following manner:

One cashiers' order will be encashed to settle part of the preliminary deposit of one specified residential property. If the number of specified residential properties a Registrant purchases is more than the number of cashiers' order(s) submitted, the Registrant shall submit on spot the number of cashiers' order(s) (of the same payee and amount as a cashiers' order(s) submitted with the Registration of Intent) in respect of each such extra specified residential property to settle part of the preliminary deposit of that extra specified residential property (the balance to be paid by cheque(s)).
