- 1. First come first served. Any person interested in purchasing any of the specified residential properties ("**Prospective Purchaser**") (if the Prospective Purchaser is a company, then any one of its directors) must:-
 - (a) personally attend ICC 62/F Venue; and
 - (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary.
