Any person interested in purchasing any of the specified residential properties (“<b>Prospective Purchaser</b>”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> <li>(a) personally attend the PARK CIRCLE Venue; and</li> <li>(b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <u>Prospective Purchaser</u>. Each cashier order shall be in the sum of HK\$100,000 and made payable to “MAYER BROWN”.</li> </ol> </li> <li>2. or more Preliminary Agreement(s) for Sale and Purchase of the specified residential property(ies) successfully selected by him/her/it. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).

5. The Vendor reserves the right to close the PARK CIRCLE Venue at any time if all the specified residential properties have been sold out.
  6. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 5:00 p.m. on any date of sale, for the safety of the Prospective Purchasers and the maintenance of order at the PARK CIRCLE Venue, the Vendor reserves its absolute right to close the PARK CIRCLE Venue. Details of the arrangement will be posted by the Vendor on the website (<http://www.parkyoho.com/napoli/en/>) designated by the Vendor for the Phase. Prospective Purchasers will not be notified separately of the arrangement.
  7. In the event of any discrepancy between the English and Chinese versions of this Sales Arrangements, the English version shall prevail.
1. 先到先得。何有意購買指明住宅物業的人士（下稱「準買方」）（如準買方是公司，則其任何一位董事）須遵從下列程序：

| Other Matters:<br>其他事項： | <p>On 18 May 2021 to 21 May 2021 (10:00 a.m. to 7:00 p.m.), Prospective Purchasers are offered and invited to view the specified residential property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the specified residential property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as “<b>Properties for Viewing</b>”). In order to maintain order at PARK CIRCLE Venue and ensure the smoothness of the selection and purchase procedures, after a Prospective Purchaser has selected a specified residential property, the Prospective Purchaser will be required to proceed with the signing of Preliminary Agreement for Sale and Purchase of that specified residential property, and that specified residential property will not be held for the Prospective Purchaser’s viewing of any of the Properties for Viewing prior to the signing of the Preliminary Agreement for Sale and Purchase.
