**(II) Submission of Registration of Intent**

1. Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties (“**Registrant**”) must follow the procedures below.
2. Registrant must submit the following:-
  - (a) only one Registration of Intent duly completed and signed by the Registrant;
  - (b) Registration of Intent shall be accompanied with either one (1) or two (2) cashier orders. Each cashier order shall be in the sum of HK\$100,000 and made payable to “Woo Kwan Lee & Lo”; and
  - (c) a copy of the Registrant’s H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to **ICC 62/F Venue** after relevant price lists of the specified residential properties are made available till 6:00p.m. on 21 June 2019 during office hours (i.e. from 11:00a.m. to 8:00p.m. (daily)). The closing time for submission of Registration of Intent will be 6:00p.m. on 21 June 2019. Late submission or submission outside the office hours will not be accepted.

**(III) Procedures for Session 1**

3. Registrants interested in purchasing any of the specified residential properties that will be offered to be sold in Session 1 must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II), (III) and (V) of this Sales Arrangements.
  - (i) The results of the first round balloting, including “registration number”, “division of sub-group”, “check-in timeslot for each sub-group” will be posted by the Vendor at the ICC 62/F Venue and 3/F, Lobby International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Registrants will not be separately notified of the ballot results.
4. (a) On the first date of the sale, Registrant who holds a valid Registration of Intent (if the Registrant comprises corporation, then all directors of that corporation) (or (if the Registrant is an individual) his/her/its/their attorney duly appointed pursuant to a validly executed power of attorney in a form prescribed by the Vendor (a “**duly**”

**appointed attorney**")) shall personally attend the ICC 11/F Venue between 9:00 a.m. and 10:00 a.m. (in accordance with the balloting session which shall take place at or after 8:00p.m. on 21 June 2019 at ICC 62/F Venue for the purposes of dividing the Registrants into one or more sub-group(s) (The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 62/F Venue and/or facilitating smooth operation of the balloting procedures, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the ICC 62/F Venue. Registrants will not be notified separately of such changes). The results of the first round balloting, including "registration number", "division of sub-group", "check-in timeslot for each sub-group" will be posted by the Vendor at the ICC 62/F Venue and 3/F, Lobby International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Registrants will not be separately notified of the ballot results).

- (b) For the purpose of verification of identity, Registrant (or (if the Registrant is an individual) a duly appointed attorney) must bring along the original receipt of the valid Registration of Intent and his/her original H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s). The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the lobby on 3/F, 48/F, 49/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (the "**Additional ICC Venues**") and/or ICC 62/F Venue to accommodate some of the Registrants by making announcement at ICC 11/F Venue and/or ICC 62/F Venue and/or the Additional ICC Venues. Registrants who arrive at the ICC 11/F Venue or (if directed by the Vendor) the Additional ICC Venues/ICC 62/F Venue beyond their "check-in timeslot for each group" shall not be eligible to participate in this Session.
- (c) (If the Registrant comprises corporation) if after the submission of Registration of Intent there is any change in the directorship of the corporation, the Registration of Intent shall become invalid immediately and the Registrant shall not be eligible to participate in this Session.

5. After verification of the identity of the Registrants,

- (a) The order of priority for selection of the specified residential properties will be determined by the number of specified residential properties which a Registrant intends to select and purchase as indicated to the Vendor on spot (in descending order);

(IV) Procedures for Session 2

7. Balloting will be used to determine the order of priority. Registrants interested in purchasing any of the specified residential properties that will be offered to be sold in Session 2 must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II), (IV) and (V) of this Sales Arrangements.
8. Registrants who have not selected and purchased any specified residential property in Session 1 will be allowed to participate in Session 2. For the avoidance of doubt, the following Registrants will NOT be allowed to participate in Session 2:
  - (a) Registrants who have purchased specified residential properties in Session 1;
  - (b) Registrants who have selected specified residential properties in Session 1 but eventually do not enter into Preliminary Agreement for Sale and Purchase of the specified residential properties so selected; and
  - (c) Registrants who have decided not to select and purchase specified residential properties in Session 1 while the remaining specified residential property(ies) is/are available for selection and purchase in compliance with the rules set out in the Abstract in Section (I).

10. Balloting will take place in batches:
  - (a) First round balloting (for dividing all Registrants into one or more sub-group(s))
    - (i) The first round balloting will take place at or after 8:00 p.m. on 21 June 2019 at ICC 62/F Venue for the purposes of dividing the Registrants into one or more sub-group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 62/F Venue and/or facilitating smooth operation of the balloting procedures, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the ICC 62/F Venue. Registrants will not be notified separately of such changes.
    - (ii) The results of the first round balloting, including “registration number”, “division of sub-group”, “check-in timeslot for each sub-group” will be posted by the Vendor at the ICC 62/F Venue and 3/F, Lobby International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Registrants will not be separately notified of the ballot results.
  - (b) Second round balloting (for determining the order of priority of Registrants in selecting and purchasing specified residential properties)
    - (i) The second round balloting for the group(s) of Registrants will take place on the first date of the sale in batches at the ICC 11/F Venue at the beginning of the relevant “check-in timeslot for each group” as posted by the Vendor pursuant to sub-paragraph (a)(ii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 11/F Venue and/or the Additional Venues/ICC 62/F Venue (if applicable) and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be announced and/or posted at the ICC 11/F Venue and/or the Additional Venues/ICC 62/F Venue (if applicable). Registrants will not be notified separately of such changes.
    - (ii) For the purpose of verification of identity, Registrant (or (if the Registrant is an individual) a duly appointed attorney) must bring along the original receipt of the valid Registration of Intent and his/her original H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s). The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the Additional ICC Venues and/or ICC 62/F Venue to accommodate some of the Registrants by making announcement at ICC 11/F Venue and/or ICC 62/F Venue and/or the Additional ICC Venues. Registrants who arrive at the ICC 11/F Venue or (if directed by the Vendor) the Additional ICC Venues/ICC 62/F Venue beyond their “check-in timeslot for each group” shall not be eligible to participate in this Session.

- (iii) (If the Registrant comprises corporation) if after the submission of Registration of Intent there is any change in the directorship of the corporation, the Registration of Intent shall become invalid immediately and the Registrant shall not be eligible to participate in this Session.
- (iv) For the purpose of the second round balloting, every Registration of Intent shall be allotted one lot per cashier order submitted with the Registration of Intent. The results of the second round balloting, including “registration number” and “ballot result sequence” will be announced and/or posted by the Vendor at the ICC 11/F Venue and/or the Additional ICC Venues/ICC 62/F Venue (if applicable). Registrants will not be separately notified of the ballot results.
- (v) Registrant who leaves the ICC 11/F Venue and/or the Additional ICC Venues/ICC 62/F Venue (if applicable) while his/her/its/their group is in sessions for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties and his/her/its/their order of priority shall lapse immediately.

11. (a) Immediately after the balloting, Registrants shall **personally** (or (if the Registrant is an individual) a duly appointed attorney) select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time.
- (b) The Registrants (or (if the Registrant is an individual) a duly appointed attorney) shall **in compliance with the rules set out in the Abstract in Section (I) above** select and purchase not more than two specified residential property(ies), otherwise his/her/their order of priority shall lapse automatically and he/she/they will no longer be eligible to participate in this Session.
- (c) If the number of specified residential properties the Registrant purchases exceeds the number of cashier orders submitted with the Registration of Intent, the Registrant shall submit on spot to the Vendor one cashier order for each extra specified residential property. Each cashier order shall be in the sum of HK\$100,000 and made payable to “Woo Kwan Lee & Lo”.
- (d) If the Registrant has successfully selected any of the specified residential properties in compliance with the rules set out in the Abstract in Section (I), the Registrant shall **personally** (or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected specified residential property(ies).

(V) General Procedures

12. Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration will not be accepted. The Registration of Intent is personal to the registrant and shall not be transferable. The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent is valid and should be included in balloting.
13. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
14. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.
15. If an individual registrant has selected two (2) specified residential properties, prior to the signing of one or more Preliminary Agreement(s) for Sale and Purchase to purchase such specified residential properties, the individual registrant may notify the Vendor on spot to add and/or delete individual(s) signing the Preliminary Agreement(s) for Sale and Purchase , but subject to the following:
- (a) the registrant will not be allowed to first delete and then add individual(s) signing the Preliminary Agreement for Sale and Purchase;
  - (b) if a registrant wishes to add any individual(s), then prior to adding of any individual(s) all the individual(s) comprised in the registrant must be **close relative(s)** (i.e. spouse, parents, children, brothers, sisters, grandparents and grandchildren) of each other and the additional individual(s) must be the close relative(s) of ALL the individual(s) comprised in the Registrant Slip and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final;
  - (c) if a registrant wishes to delete any individual(s), then prior to deletion of any individual(s) all the individual(s) comprised in the registrant must be the close relative(s) (i.e. spouse, parents, children, brothers, sisters, grandparents and grandchildren) of each other and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final.

All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally (or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add and/or delete any individual(s).

16. After completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, if a registrant has not purchased any specified residential property, his/her/its/their unused cashier order will be available for collection by the registrant (or his/her/its/their authorized person) at the ICC 62/F Venue from 24 June 2019 to 25 June 2019 during 2:00 p.m. to 8:00 p.m.. The registrant must bring along the H.K.I.D. Card(s)/Passport(s) of the registrant (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order is collected by the authorized person), (if applicable) copy of Business Registration Certificate, the original receipt of Registration Slip, and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.
17. After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person (including individuals, corporations or otherwise) interested in purchasing the specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).
18. The Vendor reserves the right to close the ICC 11/F Venue and the Additional ICC Venues (if applicable) at any time if all the specified residential properties have been sold out, provided that the ICC 62/F Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 16 above.
19. If Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 9 a.m. and 8 p.m. on the date on which Registration of Intent may be submitted and/or the first date of the sale, then, for the safety of the registrants and the maintenance of order at the ICC 11/F Venue and/or the Additional ICC Venues (if applicable) and/or ICC 62/F Venue, the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the ICC 11/F Venue and/or the Additional ICC Venues (if applicable) and/or ICC 62/F Venue. Registrants will not be notified separately of the arrangement.

**On 23 June 2019 and thereafter:**

20. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting).
21. The Vendor reserves the right to close the ICC 11/F Venue and the Additional ICC Venues (if applicable) at any time if all the specified residential properties have been sold out, provided that the ICC 62/F Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 16 above.
22. If the Vendor postpones the first date of the sale to such other date pursuant to this Sales Arrangements, the subsequent dates of sale will be postponed accordingly.

If Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 9:00 a.m. and 8:00 p.m. on any date of sale (other than the first date of the sale), for the safety of the registrants and the maintenance of order at the **ICC 62/F Venue**, the Vendor reserves its absolute right to close the **ICC 62/F Venue**.
