First come first served. Persons interested in purchasing must personally attend the designated place where the sale will take place.

On 7 June 2025: Vendor does not accept any person interested in purchasing having queued up before 2:00 p.m.

From 8 June 2025 and thereafter: Vendor does not accept any person interested in purchasing having queued up before the time of sale (according to the place where the sale is to take place).

But the Vendor, in order to maintain order at the sales offices, reserves the right to determine any method (including balloting) that the particular specified residential property will be sold.

Where, in any circumstances, a person is or 2 or more persons are interested in purchasing a particular specified residential property or specified residential properties then available, that person or the Interested Group (as hereinafter defined) who wishes to purchase the higher number of the specified residential properties shall have the higher priority to proceed with the purchase.

“Interested Group” shall mean the group comprising any one or more of the following persons :-

- (1) for individual, any Related Person (as hereinafter defined) of the interested person; and/or
- (2) for corporation, (i) any company of which the interested person is the shareholder or one of the shareholders, and/or (ii) any company of which the Related Person of the interested person is the shareholder or one of the shareholders.

“Related Person” shall mean a spouse, parent, child, sibling and other person as considered by the Vendor as related to a person.

Purchasers have to bring along with the relevant supporting document(s) as a proof as a member of the Interested Group to the satisfaction of the Vendor. The Vendor’s decision regarding the scope of the Interested Group shall be final. In any event, the Vendor's decision in this regard shall be final and binding on all persons.

The Vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).

The Vendor reserves the right to reject the entry of any person into the designated venue. The Vendor's decision in this regard shall be final and binding on all persons.
