(a) In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential property(ies) to any person(s) interested in purchasing any particular specified residential property(ies) by any method (including but not limited to balloting).
如有任何爭議，賣方保留絕對權利以任何方式(包括但不限於抽籤)分配任何指明住宅物業予任何有意欲購買人士。

(b) For the safety and the maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued or where the Vendor considers that there being any event or circumstances affecting or which may affect the safety, order or public health in the Sales Office and/or the vicinity of any of foregoing, postpone, extend or modify the date, time, period, deadline or place of sale or selection of specified residential properties or other procedure to such other date, time, period, deadline or place as the Vendor may consider appropriate. Details will be will be released by such manner determined by the Vendor and interested persons will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
