1. Balloting and Selection

- a) Balloting will be used to determine the order of priority. Details are as follows; 優先次序將以抽籤方式決定。詳情如下;
- b) Persons interested in purchasing must personally attend the Sales Office between 10:00 a.m. and 11:00 a.m. on the First Date of the Sale and submit the Registration of Intent duly completed and signed by each registrant:

- c) (i) Each registrant or group of registrants can submit a maximum of one (1) Registration of Intent. Duplicated submission will not be accepted; 每名登記人或每組登記人只可遞交最多 1 份「購樓意向登記」,重複遞交將不會受理:
