The Vendor has absolute right to change the tender closing date and/or time in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.
- (b) Persons interested in submitting tenders of the specified residential properties are reminded to examine the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because
