<p>1. <u>Balloting and Selection</u> 抽籤及揀樓</p>
<p>a) Balloting will be used to determine the order of priority. Details are as follows; 優先次序將以抽籤方式決定。詳情如下；</p> <p>b) Persons interested in purchasing must personally attend the Sales Office between 10:00 a.m. and 11:00 a.m. on the First Date of the Sale and submit the Registration of Intent duly completed and signed by each registrant: 有意認購的人士必須於出售日期首日上午 10 時正至 11 時正親臨售樓處遞交已填妥及已由每名登記人簽署的「購樓意向登記」；</p>

- c) (i) Each registrant or group of registrants can submit a maximum of one (1) Registration of Intent. Duplicated submission will not be accepted;
每名登記人或每組登記人只可遞交最多 1 份「購樓意向登記」，重複遞交將不會受理；
- (ii) If a registrant is an individual who has submitted a Registration of Intent in his/her own name, such registrant is NOT allowed to submit Registration(s) of Intent jointly with other individual(s);

- (iii) If the registrant is a company, a copy of its Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and a copy of the H.K.I.D. Card(s)/Passport(s) of such director(s) should be submitted;

- d) Upon successful registration, registrant shall be given a Receipt (“**the Receipt**”). The Receipt is personal to the registrant and shall not be transferable;

- e) The order of priority for selection of the specified residential properties will be determined by balloting at Sales Office after 11:00 a.m. on the First Date of the Sale. The registration number shown on the Receipt (“**Registration Number**”) shall be used for balloting. The ballot results, including Registration Number and selection priority (“**Selection Priority**”) shall be posted at the Sales Office. Registrants will not be separately notified of the ballot results;
