#### Other Matters:

- (a) The Vendor does not undertake and is under no obligation to review, consider or accept the highest tender or any tender at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any tender. The Vendor has the absolute right to accept any tender at or before the tender closing date and/or time. The Vendor has absolute right to change the tender closing date and/or time in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.
- (b) Persons interested in submitting tenders of the specified residential properties are reminded to read-examine the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the acceptance period after the tender closing date of that previous tender exercise.
- (c) Please note that entry of any person into the Location of Tender Box will be subject to satisfactory check of **normal** body temperature on-site. Any person entering into the Location of Tender Box is required to wear a self-provided **satisfactory** surgical face mask at all times while at the Location of Tender Box. No face mask will be provided by the Vendor on-site. The Vendor reserves the absolute right and discretion to determine whether a person's body temperature is "normal" or "satisfactory" and whether a person's surgical face mask is of "satisfactory" standard, and to deny entry of any person who fails to meet the aforesaid requirements. The Vendor's decision in this regard shall be final and binding on all persons.
